## DONOR FAQs

What is Sagamore Institute? Sagamore is an Indianapolis-based public policy research organization that promotes education excellence. Sagamore's Scholarships for Education Choice program is certified by the State of Indiana as a Scholarship Granting Organization (SGO).

Is there a limit to how much I can give and still receive the tax credit? No, there is no limit on your donations. The credit is applied to your state tax liability. It may be carried forward up to nine subsequent years, but may not be carried back or refunded.

Who receives the scholarships? Indiana K-12 students who meet the income eligibility guidelines and attend a participating school.

Can I designate a school or student to receive my gift? Yes, and no. You may designate one of our participating schools to receive your gift. However, SGO donations may not designate a particular student; this would be considered a tuition payment and is not eligible for a tax credit.

My giving to Sagamore SGO achieves an important objective of targeting my giving to benefit those who desire to have more educational choices. I also feel strongly that it can equip parents with more options so they can make the best educational decision for their children and their family."
